



2016–2017 Loan Repayment Estimates: \$100K or More

Standard Repayment Plan

The following chart will help you estimate the repayment amount of student loans that have a principal balance of \$100,000 or more under the **Standard Repayment Plan** (estimates for Extended Repayment Plan shown on next page). The Standard Repayment Plan term is 10 years, so under this plan, you'll make 120 payments before the loan is paid off. Contact your loan servicer if you are having trouble making your payments, or if you want to learn about other repayment options. To determine the total amount to be repaid, add the interest accrued to your total amount borrowed. For example, the total repayment amount of a loan of \$100,000 at a 6.31% interest rate would be \$135,100 (\$100,000 principal and \$35,100 interest).
